Digital Hospital Ward

The aim of the coursework is to design and implement a user interface for a tablet for viewing the vital signs of the patients monitored by wireless sensors in a hospital ward of the future.

The current practice in a hospital ward is for nurses to record at regular intervals clinical observations of the patient's vital signs in a chart. This data is used to compute a partial Standardised Early Warning System (pSEWS) score which when combined with observations of the patient's stimulus-induced responses results in the final SEWS score. The value of the SEWS score informs the actions of the medical staff.

Imagine a hospital ward in the future where the vital signs of the patients: respiratory rate (breaths/minute), oxygen saturation (%), temperature (°C), systolic blood pressure (mmHg) and heart rate (beats/minute), are monitored continuously using wireless sensors and transmitted to a tablet. The pSEWS score is calculated based on the figures in Table 1 [1]. For example, a patient with the following values of the parameters: respiratory rate = 29, oxygen saturation = 92%, temperature = 38.5, blood pressure = 82/65, and heart rate = 112, has a pSEWS score of 7.

Stage 1 - Patient-View – You can either import the compressed file **Coursework2.zip** into NetBeans on a DICE machine, or if you find it more convenient, you could use the following virtual machine which has the environment set and will be used for testing your submissions: (user_name: student, pass: hci) it's recommended to be used with Virtual Box https://drive.google.com/folderview?id=0Bz_h5mvuiVXSV110VC02QkVaWkU&usp=sharing).

Design a user interface to display the following information for each patient: First name, Last name, Sex, Date of birth, and the five parameters listed in Table 1 displaying live data. The names and details of the patients are listed in the file **data/patientList.csv**.

You are required to implement the function **displayData()** in the file **PatientJFrame.java**. Record in the file **patientview.pdf** (in less than 300 words) justifications of your design in terms of HCI design principles using annotated screen shots as reference.

[Marks – 20%]

Stage 2 – Ward-View – Design a user interface in **WardJFrame.java** for a ward consisting of six beds.

You are required to calculate the pSEWS value for each patient as described previously, and use a traffic-light model for displaying the values : 0 – 1 : green; 2 – 3 : amber; 4+ : red.

An amber or red pSEWS value should alert the nurse to examine the patient's response to external stimulus, and provide the following information about the patient state in a drop-down menu (value in brackets): Alert (0), Verbal (1), Pain (2), and Unresponsive (3).

The pSEWS value is augmented appropriately based on the nurse's response in the drop-down menu, to display the full SEWS value.

The following course of actions should be displayed based on the SEWS value:

2 – 3 : “Continue routine observation”

4 – 5 : “Involve the nurse-in-charge immediately”

6+ : “Call the registrar for immediate review”

The nurse should be able to switch between the ward-view and the patient-view as implemented in Stage 1 by clicking on the representation of a particular patient.

Record in the file **wardview.pdf** (in less than 300 words) justifications for your design in terms of HCI design principles using annotated screen shots as reference.

[Marks – 50%]

Stage 3 – History-View – Design a user interface in **HistoryJFrame.java** using **jFreeChart** (www.jfree.org/jFreeChart) for displaying the parameters of a patient over the last hour as found in the folder **data/patient** in a compelling way so that nurses can follow easily data trends and salient features are highlighted. Add a button to the Patient-View developed in Stage 1 to display historical data over the last hour.

Record in the file **historyview.pdf** (in less than 300 words) justifications for your design in terms of HCI design principles using annotated screen shots as reference.

[Marks – 20%]

Stage 4 – Evaluation – Describe a strategy (in less than 600 words) with justifications (**evaluation.pdf**), for evaluating your solution with potential users and the different stakeholders.

[Marks – 10%]

Submission: The deadline for submission is **16:00, 9 November, 2015**. You should compress the entire project into a file called **hci_coursework2.zip**.

Use the DICE **submit** command for submission:

```
submit hci 2 hci_coursework2.zip
```

Assessment:

Marks will be awarded for a working implementation based on a well-imagined design with clear justifications in terms of HCI design principles (consult the attached Marking Guidelines for details).
